### **1. It is a Schedule II Controlled Substance (The Highest Risk)**

Adderall is classified by the Drug Enforcement Administration (DEA) as a **Schedule II Controlled Substance**. This classification means the drug has a high potential for abuse, severe psychological or physical dependence, and must be strictly monitored.

- **Legal Consequences:** Possession or distribution of a Schedule II drug without a valid prescription is a **felony** offense under federal law. Sharing your legally prescribed Adderall is also considered distribution.

## 3. The Ryan Haight Act and Telemedicine

Federal law is designed to prevent these illicit sales. The **Ryan Haight Online Pharmacy Consumer Protection Act of 2008** requires a prescribing

practitioner to conduct an **in-person evaluation** before prescribing a controlled substance like Adderall.

- **Temporary Exception:** During the COVID-19 pandemic, the DEA temporarily relaxed this rule to allow prescription via telemedicine. **However, this temporary flexibility is subject to change and still requires a comprehensive, virtual medical evaluation and diagnosis by a licensed provider.**
- **The Bottom Line:** Any site that claims to sell Adderall without requiring an in-depth video consultation and a diagnosis from a U.S. licensed provider is operating **illegally**.
