Immediate Warning: Lortab is a Highly Controlled Substance

Lortab is a brand name for a combination prescription pain reliever containing **hydrocodone (an opioid)** and acetaminophen. Hydrocodone is classified as a **Schedule II controlled substance** by the U.S. Drug Enforcement Administration (DEA) due to its high potential for abuse and severe psychological or physical dependence.

It is illegal to buy Lortab or any product containing hydrocodone online without a valid prescription from a licensed healthcare provider.

Extreme Dangers and Legal Risks

Attempting to "Buy Lortab Online" from non-verified sources presents life-threatening health and serious legal consequences:

- **Fatal Overdose Risk:** Hydrocodone is an opioid that can cause **severe, life-threatening respiratory depression (slowed or stopped breathing)**. This risk is dramatically increased with misuse, high doses, or when combined with alcohol or other sedating drugs.
